## Orientation goal:

- To provide newly-arrived children with:
  - An overview of program expectations
  - Orientation to the roles of social workers and foster families
  - An understanding of foster family expectations
- To assess the child's needs and goals

#### Introduction to Foster Care

- What are child's beliefs about foster care?
- What does foster care mean in the United States?

#### Roles and Responsibilities

- Social Worker
- Foster Parent
- Child
- Other professionals--doctors, teachers, counselors, interpreters, immigration attorneys

## Orientation to Family Living

- Home walk through
- Chores\*
- Family schedules

#### Other Services

- Medical, dental, immunizations
- Education and school enrollment
- Counseling
- Court process
- Independent living services
- Cultural gatherings and ethnic community

#### Strengths and Needs Assessment

- Child's emotional and familial strengths
- Child's beliefs about foster care
- Medical or other issues requiring attention
- Cultural and religious needs, and how foster family will meet

#### Strengths and Needs Assessment, cont.

- Overseas URMs:
  - Understanding camp experience, search for family members
- For Trafficking Victims:
  - Safety planning with foster family
  - Risk of contact with traffickers
  - Contact with family of origin

#### Strengths and Needs Assessment, cont.

- For former DUCS youth:
  - How is URM placement different from DUCS?
    - Legal status
    - URM benefits
    - Voluntary post-18
    - More opportunities to pursue education

#### Follow Up and Ongoing Orientation

- Continue needs assessment and any areas of concern
- Discussion of areas of conflict
  - Independence vs. family structure
  - Chores
  - Food
  - Communications styles
  - Gender roles

## Follow Up and Ongoing Orientation, cont.

- Laws in the United States and how they differ from home country
- Introduction to broader community settings
- Older youth: shift focus to tasks of independent living through group and individual work

#### Strategies for Successful Orientation

- Clear expectations at the beginning lead to better adjustment in foster care
- Ongoing orientation facilitates gradual acclimatizing

#### Resettlement Challenges

- Preconceived notions of U.S. lifestyle
- Frustration with grade placement in school
- Family roles, gender roles, push towards independence
- Former DUCS youth--expectations of greater freedom
- Overwhelmed by their tasks and challenges
- Finding their place, new bicultural identity

### **Future Strategies**

- Group orientation
- Mentoring program
- Video on life in the U.S. for youth overseas and in shelters
- Consult with CO instructors for current URMs
